President, Randal Bublitz, acted as Chairperson of the meeting and Donna Armour recorded the minutes.

The requirements for a quorum having been met, the meeting was called to order at 9:05 am on Wednesday, October 29, 2025 for the purpose of action on the following agenda items:

AGENDA ITEM 1: Treasurers Report, Submitted by Chris Hughes

The current bank balance is \$160,815.06.

AGENDA ITEM 2: Annual Meeting, Submitted by Chris Hughes

Chris submitted a request to Orchids & Onions on Facebook for good meeting places. We were not happy at all with the price or service we received last year at the DamBar. The Masonic Lodge downtown on 4th Street turned out to be a very good place and the price for the room is only \$150.00. There were several options for catering and it was decided to go with one of the brothers of the Masonic lodge who just happens to be a caterer.

The meeting room is upstairs but the building has a lift that we can use to help anyone upstairs that has a problem climbing stairs. A motion was made and seconded to approve the Masonic lodge and catering for this years annual meeting.

AGENDA ITEM 3: Budget Review, Submitted by Chris Hughes

The budget from last year was reviewed and a few changes were made based on future need for legal services for collecting from delinquent owners. Once it is revised it will be sent to the board via e-mail for review and then the approved copy attached to these minutes. See Addendum A & Addendum B.

AGENDA ITEM 4: Foreclosure Update, Submitted by Donna Armour

Currently there are 5 delinquent owners that we are proceeding with foreclosure on their properties to reimburse the POA for monies owed. Following is an update from Tom Price, the Attorney for the POA.

Adv. DeMatteis

Working on service. We are attempting to locate good contact information in which to serve Mr. Bailey. If we cannot get him personally served, we will need to publish. If we have to publish, then our next step for default would not be until approximately mid to late January.

Adv. Hayden

Working on service. Litchfield Financial Corporation has been served and can be defaulted on October 18th. We are attempting to locate a process server in Kirkland, Arizona to serve Arizona Land and Ranches, Inc. Several attempts at service have been made on the Haydens and I believe Mrs. Hayden is avoiding service. I have filed a motion with the court to grant me permission to do an alternative service. I have not received that court order yet.

Adv. Bache

Defendant's son, Marc Bache, has been served. I cannot default him until mid-November. As you know, we are in the process of maybe working out a payoff with Marc Bache.

Adv. Tolea

The Summons and Complaint are with the process server. I believe they may be served already. I received an October 14th update from the process server that I should be receiving my affidavit of service soon. I'll know more once I receive that affidavit.

Adv. Yerkey

Due to the fact of how the invoices were written up, I cannot file the Complaint until after November 30th."

AGENDA ITEM 5: Annual Assessment Review, Submitted by Chris Hughes

Since the current bank balance is adequate to support the Association responsibilities.

A motion was made and seconded to approve the Annual Assessment amount remaining at \$230.00.
